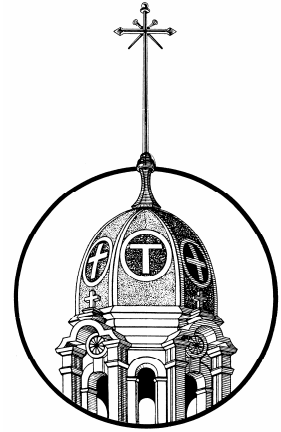

CWCF Grant Application



The *Francis Eugene Cardinal George Grant* was funded by the Board of Trustees of the Central Washington Catholic Foundation to assist Catholic schools, parishes, agencies and fraternal groups in Benton, Chelan, Douglas, Grant, Kittitas, Klickitat, or Yakima counties. Presently, a winning grant recipient could expect \$100 to \$1,500 awarded.

Qualifications for this grant:

1. The school, parish, agency, or group must be a participating member in the Roman Catholic Community,
2. A resident of Benton, Chelan, Douglas, Grant, Kittitas, Klickitat, or Yakima counties,
3. Grant money can only be used in these counties,
4. No grant proposal can be of a personal nature or benefit monetarily any specific individuals or groups,
5. Grant money can only be used for that specific purpose,
6. No grant money can be used for salaries, debt reduction, bills, or operational expenses.

Successful application includes:

1. Completed application form and all accompanying documentation mailed directly to the *Central Washington Catholic Foundation* and post marked **no later than January or September 15th** of the year the grant is awarded,
2. Signature of Director/Pastor/Principal/President attesting to the need of this grant proposal,
3. Detailed information on how the grant money would be used,
4. One letter of recommendation, other than the person submitting the proposal or Director/Pastor/Principal, who will attest to this need.

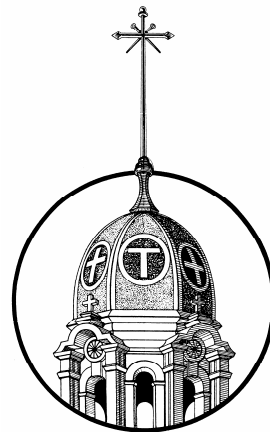

An applicant may submit no more than two additional pages of pertinent information, i.e. flier, catalog page, company estimate sheet, etc.

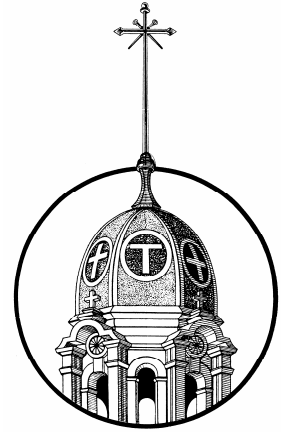

CWCF Grant Terms and Conditions

The **CWCF Grant** to your organization from the *Central Washington Catholic Foundation* (CWCF) is solely for the purpose described in your application and is subject to your acceptance of the following terms and conditions:

1. Funds are to be used only for the express purpose described in the proposal and must be consistent with Catholic moral teachings. The CWCF must approve any modifications in advance.
2. The organization agrees to list the CWCF among its funders/contributors.
3. The organization gives permission to the CWCF to use the organization's name, project description, photos and other information in CWCF promotions.
4. The organization will return to the CWCF any unexpended funds. Funds will also be promptly returned if it is determined that the organization is using the funds in a manner inconsistent with Catholic moral teachings.
5. The organization will submit a written report, not to exceed two pages, which summarizes the activities where grant funds have been utilized and which provides a full accounting of the expenditures. This report is due upon expenditure of funds and no later than **90 days after receiving funds**.
